### Introduction to Safeguarding Children Training Course (Level 1 Safeguarding)

Duration: 3 hours

This course aims to help learners understand their responsibilities for safeguarding children. It explains how to recognise and respond to abuse, how to respond to a disclosure, and how to report and record concerns.

# **Advanced Safeguarding Children (Level 2 Safeguarding)**

Duration: 3 hours

This Advanced Safeguarding Children course aids those who work frequently with children and/or families to learn more about child protection procedures and responsibilities, including recognising and reporting abuse, the safeguarding structure and what happens after a referral to social care is made.

# **Designated Safeguarding Lead Training**

(Level 3 Safeguarding Children)

Duration: 3 hours

This Designated Safeguarding Lead course helps those with a designated child protection role to learn more about their responsibilities in regards to promoting good safeguarding practices in the workplace, recognising and responding to abuse, working with other services and sharing information.

#### Safeguarding Vulnerable Adults Training (Level 1)

Duration: 3 hours

This course teaches learners about their safeguarding responsibilities and how to protect vulnerable adults. It explains how to spot abuse and the full procedure to deal with it, so that all adults can be kept safe from harm.

## **Advanced Safeguarding Adults Training (Level 2)**

Duration: 1-2 hours

This Advanced Safeguarding Adults course aims to provide those with safeguarding responsibilities with a better understanding of the principles of the Care Act, how to take a person-centered approach to safeguarding, and how to identify and respond to any issues or concerns that arise amongst the adults in need that they work with.

### **Level 3 Safeguarding Adults Training**

Duration: 3-4 hours

This Level 3 Safeguarding Adults course helps those in a senior position of responsibility for safeguarding vulnerable adults, such as a manager, supervisor, or designated safeguarding lead, to learn more about their responsibilities towards these adults. This includes how to recognise and respond to abuse, work with other services, recruit staff and volunteers safely, and share information with the appropriate agencies.

### **Safer Recruitment Training**

Duration: 2-3 hours

This online Safer Recruitment Training is designed to help those who work with children to actively protect their welfare when selecting new people for the workforce. Safeguarding children is a priority for all businesses working with people under the age of 18 and it is essential that procedures are in place to ensure a fair and secure recruitment process is in place.

#### **Safer Recruitment in Education Training**

Duration: 2-3 hours

This Safer Recruitment in Education course aims to help people with responsibility for recruiting and/or supervising new staff members understand the safer recruitment process, including creating an applicant information pack, interviewing candidates and carrying out effective pre-appointment checks.

#### **Safeguarding Children in Education**

Duration: 2-3 hours

This Safeguarding Children in Education course has been designed to help those who work in education understand their responsibilities for safeguarding students. The course outlines the general indicators of different types of abuse and explains how to

#### **Autism Awareness**

Duration: 3 hoursThis course helps learners to understand more about Autism Spectrum Disorders (ASDs) so they can effectively support children in their setting. The course explains the common difficulties that autistic children face and provides tips and strategies for managing autistic behaviours.

# **Challenging Behaviour Training**

Duration: 3 hours

This Challenging Behaviour course aims to help people who work with children to understand what causes difficult behaviour. The course explains how to react appropriately in challenging situations and help the child to improve their behaviour.

### **Preventing Radicalisation and Extremism Training**

Duration: 1-2 hours

This course gives a clear and concise introduction to radicalisation and extremism in the UK, providing you with an overview of the Prevent duty, what it means for you and how to show compliance. Packed with case studies and real-world opinions, this course builds your confidence making it easy to apply the duty and support vulnerable people.

### **Child Sexual Exploitation Awareness**

Duration: 2 hours

This Child Sexual Exploitation Awareness course is designed to help practitioners understand the complexities of CSE issues and develop a knowledge of how young people become implicated, how it affects their lives and how best to respond to safeguarding concerns.

#### **Dementia Awareness**

Duration: 2-3 hours

This Dementia Awareness course has been designed to help learners understand more about the symptoms and diagnosis of dementia so they can confidently care for someone with the condition. The course provides many tips and ideas for adaptations that can be made to the person's home and lifestyle to make everyday living a little easier.

#### Safeguarding Children: Internet Safety

Duration: 1-2 hours

Internet safety for kids is a topical and significant subject. This online Safeguarding Children: Internet Safety course aims to provide an understanding of the risks that the online generation may encounter, for both professionals and parents, who wish to know more about what they can do to protect children online.

### **ADHD Training**

Duration: 3 hours

This ADHD Awareness course has been designed to provide learners with an understanding of what ADHD is, what the potential causes are, and how to manage problem behaviours and support a child with ADHD at school, at home, and in social situations.

### **Drug and Alcohol Awareness**

Duration: 1-2 hours

This Drug and Alcohol Awareness course has been designed to help those who manage people who may have problems with substance misuse. It raises awareness of drug and alcohol abuse, helps learners to spot the signs, and provides strategies and

### **Domestic Violence and Abuse Training**

Duration: 2 hours

This domestic violence and abuse training course aims to raise awareness of the reasons behind, and impact of, domestic violence and abuse (DVA) on both the adult victim and the victim's children. Domestic violence and abuse is an issue that affects the lives of many children, putting them at risk of harm and depriving them of the feelings of stability, security and consistency of care that they need. This course gives anyone that works with children and families a detailed overview of the main issues behind DVA and explains how to deal with any concerns they may have.

### **Human Trafficking and Modern Slavery**

Duration: 1-2 hours

This online training course is a clear and concise introduction to trafficking, exploitation, and modern slavery in the UK. Designed by specialists, this course teaches learners to spot trafficking, understand the perspectives of victims, organise support, and report trafficking through the NRM.

### FGM, Forced Marriage & Honour-Based Violence Awareness

Duration: 1-2 hours

This online course has been designed to help front line workers take immediate action to help victims, recognise triggers and risks, and understand why these abuses happen.

#### **Dyslexia Awareness**

Duration: 4-5 hours

This Dyslexia Awareness course gives a comprehensive understanding of dyslexia. It discusses the characteristics of dyslexia and how this affects learning, and gives guidance on how to support children who have or who show signs of dyslexia, for example through interventions, classroom modifications and seeking further advice.

# **Deprivation of Liberty Safeguards (DoLS)**

Duration: 1-2 hours

This Deprivation of Liberty Safeguards (DoLS) training course is designed to help people who work with adults in need understand their responsibilities under the Mental Capacity Act legislation. The course looks at how to promote the welfare of people who lack capacity and ensure that decisions made on their behalf are always in their best interests.

#### **Child Bereavement Training**

Duration: 2-3 hours

This Child Bereavement training course aims to help teachers and other education staff about how to support a child who is bereaved. It explains different models of bereavement, how bereaved children may act, and what you should do to support them as well as yourself.

# **LGBTQ+ Awareness Training**

Duration: 1-2 hours

This LGBTQ+ Awareness course aims to raise awareness of the issues that LGBTQ+ people can face in the workplace, and helps you to recognise the changes that can be made to create a more equal, diverse and tolerant working environment. The course covers LGBTQ+ terminology, LGBTQ+ law, and how to challenge unlawful behaviours, such as discrimination and harassment.

#### **Child Mental Health Training**

Duration: 2-3 hours

This Child Mental Health Training teaches about the common mental health problems that some children may experience. It explains how to recognise them, what to do if you think a child is struggling, and ways of promoting good mental health and wellbeing.

#### Safeguarding Children with Disabilities

Duration: 2 hours

This Safeguarding Children with Disabilities course helps professionals to understand how children and young people with disabilities may be impacted by abuse, how to recognise the warning signs and how to act on safeguarding concerns.

#### **Dignity in Care**

Duration: 3-4 hours

This Dignity in Care training course has been designed to provide learners with all the knowledge required to deliver dignified care to patients, whether in a hospital or care home. They will gain an understanding of practical methods they should use and positive attitudes to adopt in order to uphold people in care's dignity and improve their quality of life.

# Person-Centred Care

**Duration: 3 hours** 

This Person-Centred Care course educates health and social care workers about how to deliver care in a person-centred way. You learn how to adopt practical methods of adjusting care to a person's individual wants and needs, which benefits your healthcare setting and improves the patient's quality of life.

# **Child Neglect**

Duration: 1-2 hours

This Child Neglect training course aims to help professionals understand more about what neglect is and how it can cause harm to a child. The course explores why neglect happens, the warning signs to look out for, and assists learners to know how to respond to any concerns they may have about child neglect.

### **Safeguarding for Taxi Drivers**

Duration: 1-2 hours

The Safeguarding for Taxi Drivers course has been designed to offer taxi drivers an understanding of their safeguarding responsibilities. This includes how to recognise abuse and exploitation, how to report their concerns, and good safeguarding practices towards passengers.
